WEDDINGS OF 50 GUESTS OR MORE

For weddings of this size or above, the Judge's Court and the Barrister's Court are perfect for hosting the day.

The Judge's Court is used for the wedding breakfast and reception, with dancing and DJ to follow if desired.

The Barrister's Court then creates the perfect ambience for the ceremony, being then turned into a relaxed chill out room with low lighting and soft music for your guests to retire to later in the evening.

To combine these two rooms with perfect coalesce we have our beautiful mosaic tiled foyer and bar area situated between the rooms creating the ideal champagne reception area following the ceremony.

Our late license is until midnight Sunday to Wednesday and 1am Thursday to Saturday.

SMALLER WEDDINGS OF 40 GUESTS OR LESS

> If you just wish to hold your wedding ceremony at Browns Courtrooms the rooms are available on a room hire basis, please enquire within for prices.

To organise the wedding ceremony itself you will need to make a booking with the Westminster Registry Office by calling 020 7641 1162 or visit their website at www. westminster.gov.uk. It is advisable to make provisional bookings with both Browns Courtrooms and the Registrars Office before confirming the wedding. Westminster Registry Office will accept bookings for civil wedding ceremonies up to one year in advance of the ceremony date.

BOOKING & PAYMENT DETAILS

If you decide to confirm your wedding with us, we will require you to sign our terms and conditions and fill in your credit card details should cancellation charges be incurred.

A non-refundable deposit of 25% of the estimated spend is required to secure your booking. The remaining 75% of the estimated spend is payable 8 weeks before your wedding, to include the deposit. Any addition or deduction of the final bill will be charged/refunded to the credit card details supplied on the booking form.

MAXIMUM SEATING ARRANGEMENTS

The rooms can be arranged in different seating styles, depending on your requirements. Maximum numbers in each seating style and for each room are detailed below:
